


MEETING NOTICE JARU NATIVE TITLE COMMUNITY CONSULTATIONS WEDNESDAY 19TH JULY TO TUESDAY 25TH JULY 2023

The purpose of these community consultations is to give information to and talk with the Jaru native title holders about the next steps to getting exclusive native title recognised in:

- the Ord River Regeneration Reserve area (in blue on the map below) in a new Jaru native title claim (Jaru #3), and
- the Wolfe Creek Crater Reserve area (in red on the map below) inside the Jaru determination (WAD45/2012).

WHAT WILL HAPPEN AT THE COMMUNITY CONSULTATIONS

The Ord River Regeneration Reserve (in blue on the map) was originally part of the Jaru claim (WAD45/2012) and the claim group decided to remove the Jaru claim from this area because the law at the time did not allow for recognition of native title in this area. Because of the same law, the Jaru determination (WAD45/2012) did not recognise native title in the Wolfe Creek Crater Reserve (in red hatching on the map).

The law has now changed and exclusive possession native title may be recognised in favour of the Jaru native title holders in both of these areas. At these community consultations, the KLC will provide information about this process including:

- making a native title claim over the Ord River Regeneration Reserve; and
- changing the Jaru determination to provide recognition of native title in the Wolfe Creek Crater Reserve.

These meetings will not authorise a native title claim. A native title claim will not be made until after a meeting of the native title claim group to authorise the claim.

Who is this meeting for?

These meetings are for the Jaru native title holders who are recognised in the Jaru determination (WAD45/2012) and Jaru #2 determination (WAD288/2021).
