DIRECTOR APPOINTMENTS

There are currently 11 directors of the Jaru Aboriginal Corporation RNTBC (Jaru PBC). 5 directors are on 2-year term which expire at the AGM. This means at least 1 and up to 5 directors need to be appointed at the AGM. Current directors are eligible for re-appointment.

The rule book of Jaru PBC has the rules for appointing directors:

- Jaru PBC must have at least 7 directors and a maximum of 11 directors (Rule 7.1)
- Directors must be members of the Jaru PBC (Rule 7.2)
- A person cannot be a director if they are disqualified from managing Aboriginal corporations (Rule 7.3)
- Directors are appointed by resolutions passed at a general meeting (Rule 7.6)
- Directors are appointed on rotation for a 2-year term, so the appointment of approximately half of the directors expires each year (Rule 7.11)
- Directors must give their consent in writing to act as a director (Rule 7.7), using the form at Schedule 6 of the Rule Book, before the appointment takes effect

Directors must meet a certain number of times each year and govern the operations of the PBC. Directors have legal duties they have to follow, like declaring conflicts of interest and not using their position improperly.

If you want to be considered for appointment as a director of Jaru PBC you must:

- attend the 2023 AGM in person to give your consent in writing for the appointment to take effect;
 and
- have a Director Identification Number.

How to Apply for a Director Identification Number

You now need to have a Director ID <u>before</u> being appointed as a director of a PBC. This is a unique 15-digit number given to a Director that verifies your identity. You only need one Director ID number for all corporations - if you already have one for a different corporation, you use the same Director ID number for Jaru PBC.

There are three different ways you can apply for a Director ID:

- 1. **Online** use the myGovID app to log in to Australian Business Registry Services (ABRS) to fill in the online application form
- 2. **By phone** call the ABRS phone line on 1300 342 353 and enter pin 108. You will need to have your identity documents ready.
- 3. **By paper form** fill in a paper application form, attach certified copies of your identity documents, and post it to the ABRS. If you don't have enough identity documents you can get a referee to confirm they know you in another form.
