PROXIES

Members of Giniyjawarrni Yoowaniya Riwi Aboriginal Corporation RNTBC (GYR PBC) can appoint another member of GYR PBC as a proxy to attend the 2021 AGM for them. A proxy appointment needs to be in writing using the form in the Rule Book (Schedule 5) and it has to have the appointing member's name and address, GYR PBC's name, the proxy's name, the meeting where the proxy is going, and it must be signed by the member.

GYR PBC must receive proxy notice at least 48 hours before the AGM. A person can only be a proxy for 1 member. Only a GYR PBC member can be a proxy for another member of GYR PBC.

DIRECTOR APPOINTMENTS

The GYR PBC rule book has the rules for appointing directors.

To be a director of GYR PBC, you have to be a member of the PBC and not be disqualified from managing corporations under the CATSI Act (rule 7.3).

Directors are appointed by members passing a resolution at a members' meeting (AGM) (rule 7.6).

You have to give consent to be a director by filling out a form (rule 7.7).

Directors meet at least 2 times a year and are responsible for the operations of the PBC.

Directors have to know the business of the PBC and have to ask questions. Directors have other legal duties that they need to follow, like declaring conflicts of interest and not using their position improperly.
